Last++ Means: The Muslim Minority candidates those who have Not Appeared / Not Qualified in TSICET-2024 but passed the Qualifying examination (Degree with aggregate of 50% and 45%, who are claiming OC & BC status respectively).

Candidates should produce all certificates in ORIGINAL viz: (1)TSICET-2024 Rank Card & Hall Ticket (2)Degree Certificate & Memorandum of Marks (3)Memorandum of Marks of Intermediate or its equivalent (4)Memorandum of Marks of SSC or its equivalent (5)Study Certificate from 9th Class to Graduation (6)Residence certificate for preceding 7 years of the qualifying examination i.e. Graduation in respect of candidates who had private study without any institutionalized education (7)Residence Certificate of Father or Mother for a period of 10 years in A.P. excluding the period of their employment outside A.P. from M.R.O. in case of non-local candidates. (8) Muslim Minority students shall be eligible for reimbursement of Tuition Fee subject to the eligibility rules to be stipulated in due course by the Governments of Telangana and Andhra Pradesh.

Fee Particulars:

Candidates will have to pay non-refundable amount of Rs.1000/- and Rs.1500/- towards registration and counselling fee respectively. Tuition Fee as fixed by the Government of Telangana, for MBA, MCA and other related Courses. Fee shall be remitted by way of Demand Draft Drawn in favour of “**Convener, TGICET-AC-SW-II-2024 Admissions**” payable at Hyderabad or in cash at the bank counter located at the admission Centre. Fee shall be paid in full at the time of counselling and no part payment will be accepted for those students who are not eligible for Tuition Fee Reimbursement from the Govt.

Candidates are informed that they should satisfy the admission rules prescribed by the respective universities and should be prepared to pay the Tuition Fee as applicable. More number of candidates called for counseling than the seats available. Hence mere attending the counseling does not guarantee a seat.

Minority Candidates whose parental income is less than Rupees One Lakh Fifty Thousand and Two Lakhs per annum (for Rural and Urban Areas respectively) are exempted from the payment of Tuition Fee provided they furnish the Income Certificate issued by the MRO on or after 01-01-2024. (G.O. Rt. No.64, Minorities Welfare Department, Govt. of Telangana, Dated.30.04.2015)

Note:

1. This notification is itself a call for counseling. No separate call letters shall be sent to individual candidates. **The candidates may have to stay a day extra, if required.**
2. Minority Students who take admission in a college through SW-I can slide to a college in SW-II-AC and vice versa.
3. Last date for cancellation of admission taken through SW-II is 30-09-2024.
4. Last date for reporting to the respective allotted college is 28-09-2024.
